The undersigned, individually or as agent, in consideration of being allowed to participate as an exhibitor, contestant, along with the owner, lesser, trainer, manager, agents, coach, rider and horse at this BHAM sponsored show at MSU Grounds & Pavilion for myself, my heirs, executors and personal representatives hereby waive and release any and all rights, claims and damages I may have against MSU Pavilion, B.H.A.M., A.B.R.A., their agents, employees, officials and directors for any injuries or loss by me during or in connection with the show or related activities, whether or not such injury or loss resulted directly or indirectly from negligent acts, omissions of said officials/employees of MSU Pavilion, B.H.A.M., A.B.R.A., their agents and employees from any such rights and claims asserted by me or my child or anyone involved in showing a horse under our/my entry. Also, by signature hereon, I acknowledge that I am aware of the BHAM drug test program and expressly consent to the drug testing of any horse entered by me or on my behalf. I understand that failure to comply or cooperate with the program shall be interpreted as a determination of a positive test result pursuant to the drug program.
